1-Lb. Sewer Block Bait

DITRAC Super-Size BLOX comes in a 1-lb. block designed for heavy infestations of rats. Its active ingredient, Diphacinone, kills rats with less chemical than many other anticoagulants. Multiple edges on the block give rodents plenty to gnaw.

DITRAC Super-Size BLOX is mold and moisture resistant for use in damp places, such as sewers. Its weatherability prevents the bait from becoming unpalatable due to mold or rancidity.

Labelled for control of Norway and roof rats, DITRAC Super-Size BLOX contains the optimal blend of low wax and human food-grade ingredients for high weatherability and bait acceptance. It remains stable longer than cereal or pelleted baits.

DITRAC Super-Size BLOX is colored green and is authorized by USDA for use in federally inspected meat and poultry plants. A hole in the center of the Blox lets PMPs wire/nail it in place or place on bait securing rods for extra security.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

READ THIS LABEL: Read this entire label and follow all use directions and use precautions.

IMPORTANT: Do not expose children, pets, or other nontarget animals to rodenticides. To help to prevent accidents:

1. Store product not in use in a location out of reach of children and pets.
2. Apply bait in locations out of reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.
3. Dispose of product container, and unused, spoiled, and unconsumed bait as specified on this label.

USE RESTRICTIONS: For control of Norway rats in sewers. Also for control of Norway rats and roof rats in and around homes, industrial and agricultural buildings, and similar man-made structures. This product is especially suited for wet or damp areas, such as river banks, gullies, irrigation ditches, sewers, garbage dumps and landfills.

Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food. Do not broadcast bait.

SELECTION OF TREATMENT AREAS: Determine areas where rats will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Remove as much alternative food as possible.

DIRECTIONS FOR USE (Continued from other panel)

APPLICATION DIRECTIONS:

RATS: Use one bait block per placement. In sewer applications, use wire to secure block above the high water mark. Space placements at appropriate intervals—usually 15 to 30 feet apart. Maintain an uninterrupted supply of fresh bait for at least 10 days or until signs of rat activity cease.

Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and leftover bait properly. To prevent reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. **STORAGE:** Store only in original container in a dry area inaccessible to children and pets.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Completely empty carton. Then dispose of empty carton in a sanitary landfill or by incineration or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
