### PRODUCT DESCRIPTION

Eliminate cobwebs both indoors, outdoors or anywhere cobwebs are noticed with 100% natural ingredients. Cobweb Eliminator will not stain and has no long lasting odor. The mildly acidic odor noticed after application indicates the product is effectively working, and usually disappears in 24 hrs. Cobweb Eliminator deteriorates the webs' attachment points making for easy removal and maintains a neat and clean appearance. It also discourages the reformation of cobwebs. Expect 15% of webs to resurface around light sources after initial treatment, spot treatments are then suggested for best results.

### DIRECTIONS FOR USE

SHAKE WELL and do not dilute. Adjust nozzle to stream. Applications should completely wet the area, then remove the web residue with a stiff-bristle broom. Do not rinse after application. Cobweb Eliminator may be applied indoors/outdoors on paint, metal, fiberglass, concrete and masonry. Reapply as often as needed. Notice of disclaimer: The manufacturer makes no pesticidal claims with regard to this product. **INGREDIENTS APPROVED BY FDA/USDA IN ACCORDANCE WITH 21 CFR PART 182.2.** Authorization to use Cobweb Eliminator in food processing has been received from FDA/USDA.
